EMERGENCY HOUSING AND CRISIS CARE IS A FLEXIBLE PROGRAM TO GET YOUTH OFF THE STREET WHILE PROVIDING THEM WITH A CUSTOMIZED PLAN TAILORED TOWARD GETTING THEIR LIVES BACK ON TRACK. DURING THEIR STAY YOUTH RECEIVE CASE MANAGEMENT, CAREER AND EDUCATION SUPPORT, FOOD, CLOTHING, MENTAL HEALTH SUPPORT, AND OTHER WRAP-AROUND SERVICES THAT ELIMINATE BARRIERS THAT PREVENT THEM FROM MOVING TO MORE STABLE HOUSING OR REUNIFYING WITH FAMILY. YOUTH WHO ARE PREGNANT OR PARENTING RECEIVE PARENT EDUCATION AND SAFETY CLASSES TO ENSURE ADEQUATE TRAINING FOR CARING FOR THEIR CHILD.
