DURING THE 90-DAY STAY, YOUTH RECEIVE SERVICES THAT ASSIST IN STABILIZING THE CRISIS AND ENABLING THEM TO BECOME SELF-SUPPORTING ADULTS. RESIDENTS SHARE A ROOM AND HAVE ACCESS TO LAUNDRY FACILITIES, A COMPUTER LAB, A RECREATION ROOM AND A PLAYROOM FOR CHILDREN.
